About The College

Haridev College of Law, Kashipur, established in the Year 2018 run by Satguru Harirai Educational Trust (Regd.) is located in the rural area of Kashipur and approximately 4 km from Kashipur Railway Junction with the object of imparting quality legal education to the students in rural area at an affordable cost.

The college is recognized by the Bar Council of India, New Delhi and affiliated to Kumaun University, Nainital. The college presently offers three years LL.B. Course.

In order to improve the quality of teaching and learning and other service provided, the college gets feedback from students, advocates and parents as well.



Vision, Mission & Goals

Vision :

To aid development through quality legal education in rural area. The College was established in 2018 in the rural area with the object of providing access to quality legal education at an affordable cost. The college intends to serve the society and develop the region as well by organizing legal awareness and legal aid campaigns in the surrounding villages for the welfare of the society as a whole.

Mission:

To develop the competencies of students through a range of curricular, co-curricular, extra-curricular and extension activities. To provide advocacy skills to the students through teaching and motivational approach. To promote the spirit of legal research among the students.

To promote cultural, legal and ethical values with a view to promote and foster the rules of law and the objectives enshrined in the Constitution of India. To promote legal awareness in the community that will lead to greater social and economic justice.

Rules of Admission

General Rules of Admission

1. Admission must be taken in person by submitting duly filled up application form and anti ragging undertaking and by depositing the prescribed fees.
2. All admissions shall be provisional subject to confirmation from the Principal and Kumaun University, Nainital.
3. Documents to be submitted :
 - i) Self attested photocopy of 10th and 12th Marksheets and Passing Certificate
 - ii) Self attested photocopy of Graduation / Post Graduation Marksheets
 - iii) Original Migration Certificate, Character Certificate, Transfer Certificate.
 - iv) Self attested photocopy of Domicile / Resident Proof and Aadhaar Card
 - v) Self attested photocopy of Category Certificate (if belong to OBC / SC / ST)
 - vi) Gap Certificate in case of an applicant having gap in education (Affidavit)
 - vii) Anti-Ragging affidavit by student
 - viii) Declaration affidavit by student
 - ix) 5 Colour Photographs (Passport Size)

Eligibility

1. A Candidate who has passed Graduation or Post Graduation examination of any Indian University incorporated by law for the time being in force with a minimum 45% for General, 42% for OBC and 40% for SC or ST Category.
2. No Age limit

Attendance & Dress Code

The students seeking admission to LL.B. Programme is hereby informed that they are supposed to adhere to the following rules:

- A. A minimum of 75% attendance for lectures / practical is the prerequisite for grant of semester.
- B. The students are supposed to attend all the Assignment Activities / Workshops / Seminars / Training Programme / Study tour / Awareness Campus organized by the Department.
- C. The students are supposed to follow the formal dress of a legal professional as follows:
Black Trouser, White Shirt, Black Tie, Black Coat, Black Belt, Black Shoe, and Black Socks
Optional for Girl student: White salwar kameez, White dupatta, Black Coat, Black Shoe, and Black Socks.

Identity Card / Library Card

Each student will be issued an identity card and library card after his admission is sought. The identity card and library card is valid during his / her studentship. In case of loss or damage of the identity card or library card, duplicate card will be issued on request on payment of prescribed fees.

Duration of the Programme

The programme for the LL.B. Degree of the University is of Three academic years consisting of Six Semesters. Each semester will comprise of six months. The academic year start from the month of July and ends in the month of June next year. For each semester a student has to take admission afresh.

Medium of Instruction

A student is being given liberty to take any option either hindi or english.

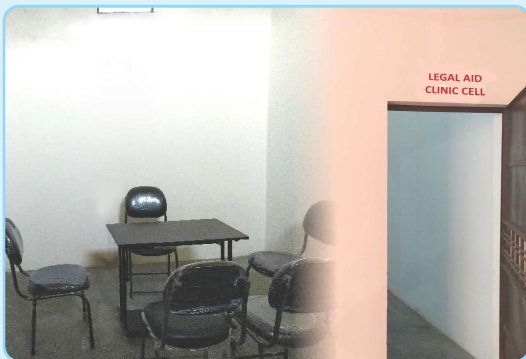
College / Teaching Hours

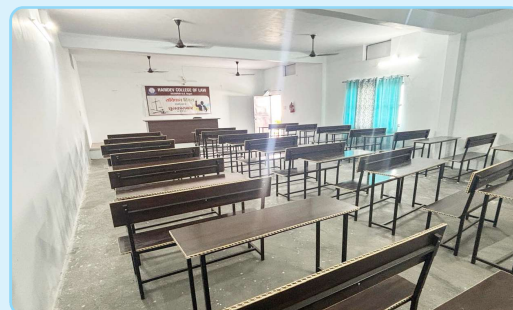
Free Legal Aid Cell

A facility of college canteen is being provided to the students wherein tea, snacks, soft drink and lunch will be made available soon.

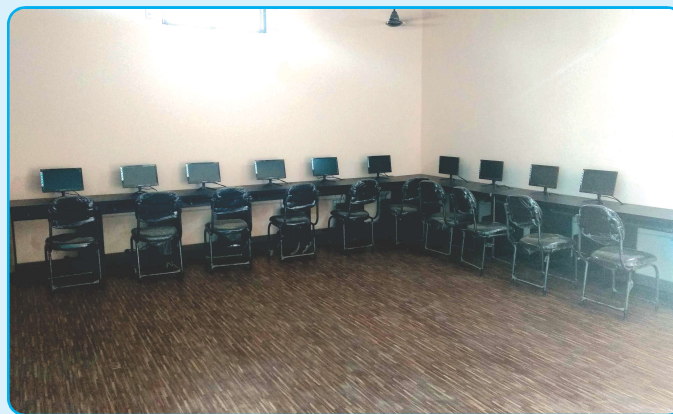


Library

Examination & Evaluation:

1. Every core paper and major elective paper shall carry 100 marks out of which 70 marks are for written examination and 30 marks for internal assessment (for practical paper 60 marks for written & 40 marks for clinical works assessment & viva)
2. Internal Assessment shall be completed within the semester itself before submission of application for end semester examination. Supplementary chances will not be there for internal assessment.

Rules & Regulations

1. Any candidate who has taken admission shall have to abide by the college rules and regulations, or any amendments made there in from time to time.
2. Eligibility criteria shall not be relaxed.
3. Applicants should get the prospectus and admission form from the college office.
4. Admission from duly filled should be submitted as per schedule of the college.
5. All the relevant in formations are shown on the Notice Board.
6. No Change of section or paper is permissible.
7. False information or concealment of information shall be a disqualification.
8. Students can interact with the Principal only during the time fixed by the Principal.
9. The Candidates should not make any payment any where accept at the college accounts office and obtain proper receipt.
10. Late and/or incomplete application or those without requisite fees or not submitted on the prescribed form shall not be entertained.
11. Candidates are required to produced the original documents such as mark sheets/certificates of the qualifying examination etc. at the time of admission for verification.
12. Smoking, chewing, drugs, plucking of flowers or fruits, damaging the college property is a punishable offence and it might lead to rustication or expulsion.
13. In case a student gets involved in any criminal case, he/she shall be expelled from the college on this ground forever.
14. Scooters, bicycles and other vehicles are permitted to be parked only in the parking place.
15. It shall be the duty of every student to maintain discipline and the dignity of the Institution. Misbehavior with teachers and other staff shall be punishable.
16. The college and its authorities do not take any responsibility of notifying and candidate individually or by post.
17. Ragging is strictly prohibited and punishable offence by the authorities as well as college.
18. Failure to complete admission process and its formalities by the prescribed date and time shall automatically disqualify the eligibility for admission.
19. Holiday Notices shall always be put up on the college Notice Board as and when required.
20. Student must preserve their original Fee Receipts, Admit Cards, Identity Card etc. because these documents are very important.
21. In the unfortunate event of theft of the vehicle or any other thing, the college shall not be liable in any form and to any extent and legal recourse i.e., filing of FIR etc. shall have to be followed by the aggrieved person only.
22. All admissions are provisional.
23. Fees except caution money once deposited by a student shall neither be returned nor adjusted under any circumstances.
24. The college shall not be responsible in any manner for the postal delays/cour/destruction.
25. If after enrolment in the college a student does not attend classes without leave for more than ten days his /her name shall be struck off the college rolls.
26. All disputes of any nature arising from any action taken by the college shall be subjected to the jurisdiction of district court, U.S. Nagar
